## REQUEST FOR ACCESS ARRANGEMENTS AND REASONABLE ADJUSTMENTS FORM

## **YEARS 11 AND 12.**

Any request for Access Arrangements and Reasonable Adjustments should initially be discussed with and the request submitted to students' subject teacher. This should be done:

- (a) For Years 11 and 12 students A MINIMUM OF 72 HOURS prior to the indicated submission due date for an assessment.
- (b) For any assessment item involving spoken or multimodal presentations A MINIMUM OF 1 WEEK prior to the indicated submission due date for an assessment.

Any request for an extension of time on the due date is not appropriate, unless there are unexpected and unavoidable medical reasons for such a submission.

Students should be able to show some evidence of a willingness to complete the assessment by the indicated submission date (e.g. notes, first draft, etc.). Final recommendations of any Access Arrangements and Reasonable Adjustments will be made by the relevant **Curriculum Middle Leader** in consultation with the **subject teacher**.

IT IS IMPORTANT TO NOTE THAT NO ADJUSTMENTS TO UNITS 3 AND 4 ASSESSMENT CAN BE IMPLEMENTED WITHOUT QCAA APPROVAL – THEREFORE IT IS IMPORTANT FOR APPLICATIONS TO BE MADE AS SOON AS POSSIBLE.
